INFORMATION & REQUIREMENTS FOR DESCENDANT REGISTRATION APPLICATION



The Descendant Registration program is available to *direct lineal descendants* (children, grandchildren, great grandchildren) of Natives of Kodiak, Inc. shareholders.

To register, descendants must submit a completed Registration form and a copy of the state-issued birth certificate establishing the relationship to a NOK shareholder. If the descendant's name differs from the name on the birth certificate or if the shareholder's name on the descendant's birth certificate is different from the name NOK has on file, copies of the legal document(s) substantiating the name change are also required (e.g., marriage certificate, divorce decree, adoption decree or other legal document).

NOK communicates with descendants through Newsletters and announcements regarding items of interest; such as, upcoming events, scholarships, and training.

Descendant Identification Cards

Registered descendants will receive Descendant Identification Cards once proof of lineal descent is confirmed. The cards specify that the bearer is a direct lineal descendant and may be helpful in assisting descendants to prove eligibility to receive services from various agencies and organizations.

The card will not specify Alaska Native blood quantum.

Descendant Responsibilities

It is the responsibility of the descendant (or custodian) to keep his/her contact information current. Please contact us promptly when you have changes to your address or name. Submit changes via phone or email.

Descendant Registration does not include voting rights or shares ownership.
