Please feel free to attach additional pages if your answers require doing so to answer completely, but please note Candidate Statements are limited to 500 words. For the purposes of this packet, and in accordance with Alaska Division of Banking & Securities requirements, "family members" are defined as your spouse, parents, children and siblings (by blood or adoption). Listing of first cousins is optional.

To be considered for inclusion within NOK's 2023 Proxy Materials, your completed Candidate Packet must be received by NOK's Kodiak office by 5:00 p.m. AKDT June 2, 2023.

It is important to note NOK reserves the right to conduct a background check on any candidate for the NOK Board of Directors and that, as part of NOK's established policy, all Board candidates are required to pass a drug test demonstrating freedom from any illegal drug use before being allowed to run for a Board seat. It is also important to note that members of the NOK Board of Directors serve as Trustees of the Natives of Kodiak Shareholder Permanent Fund Trust (SPFT) and the NOK Benefits Trust (BT), in accordance with 2018's SPFT Restated Agreement and BT 2018 Agreement.
